# USING PRESCRIBED BURNS TO IMPROVE RANGELAND HEALTH

Prescribed burns are the use of fire in a controlled manner for a pre-determined purpose. They are applied to a specific area under certain weather conditions and managed to minimize risks and maximize benefits.

Healthy rangelands need biodiversity. Rangelands evolved with fire, so their biodiversity is fire-dependent. Fire suppression has caused many rangeland ecosystems not to function properly. Prescribed fires can mimic the historical fire regime and restore rangeland soil and vegetation. In turn, this improves rangeland uses such as grazing/livestock production and leads to better wildlife habitat.

There are numerous benefits to controlled burns, such as removing invasive plants, reducing brush encroachment, increasing forage amounts/crude protein levels and therefore palatability for livestock, decreasing buildup of dead plant fuel loads that may cause high-intensity wildfires, improving plant diversity/maintaining native species, promoting perennial regeneration, improving seed germination, and enhancing water infiltration.




